ACTIVITIES

Singapore – Dialogue Sessions

In the course of the year, we would participate in various dialogue sessions organized by IPOS. Patsy Koh is the AIPPI representative in charge of collecting and collating comments and contributions and submitting these to IPOS.

TM Dialogue Session

AIPPI participated in the Dialogue Session between IPOS and AIPPI, APAA and the IP committee of the law society of Singapore on Trade Mark matters on 15 October 2007.

The AIPPI Forum & Exco Meeting 2007 was held in Singapore from 4th to 9th Singapore 2007 at the Raffles City Convention Center.

We saw participation of almost 900 delegates and accompanying persons with attendance at the Forum at about 650.

The Forum was formally opened by Associate Professor Ho Peng Kee, Senior Minister of State for Law and Home Affairs. In his speech, Professor Ho alluded to the growth of intellectual property, particularly in Asia as a vital economic and trade consideration and a sensitive political factor in international relations. This is particularly so for Singapore, as she develops to capitalize on her human resources and intellectual assets to participate in the knowledge-fuelled global economy.

The Closing event of the Forum which was also the Welcome Reception of the Exco Meeting was opened by Ms Liew Woon Yin, who is the Director General of IPOS.

Ms Liew also provided a soft copy of her speech delivered at that event and this was duly forwarded to AIPPI.

Forum: Scientific Program

The Scientific Program Committee worked with the Program Committee to formulate the topics for discussion at the Forum and then (with help from other subcommittee members) provided a number of speakers for the Forum.

Budget

The organizing committee worked assiduously on the budget throughout the period running up to the meeting to try to effect costs reduction and correction of errors found in the budget.

Up to just before the meeting, there were budget cuts effected of almost SGD225,000.

There were however unexpected costs incurred in the course of the meeting – and the final budget is still not completely finalized.

We have also applied for a grant from STB – totally about SGD48,000 and as of today – we have passed the formalities section of STB and are still awaiting the final approval to be issued.

Social Committee

There were many social events since the Meeting was really 2 Meetings held back to back. The opening of the Forum was held at Chijmes Hall and the Closing of the Forum and the Opening of the Exco was held at the Asian Civilizations Museum. The evening out for the Exco was held at the Night Safari and the Closing Gala was at the RCCC.

The Social committee worked really hard in ensuring that all the social events passed off without a hitch – and they checked very thoroughly all the conditions of everything- including toilet facilities and water – to ensure the comfort and enjoyment of our delegates.

General Feedback and Comments

The general feedback and comments received from the delegates was that the meeting in Singapore was a really good one, and that it was extremely well organized and enjoyable. They all enjoyed Singapore as a city as well.
